To: Essex County 4-H Members, Leaders and Parents

Re: Essex County Fair

The Essex County Fair is scheduled for August 14-18, 2024. *Sunday will be a full day of operation.* The 4-H Exhibitor's Handbook contains all rules and classes for exhibiting at Fair. There are two separate books for 4-H and fair open classes. This is the 4-H Exhibitor's Handbook - the open classes are in a separate Fair Exhibitor's Handbook. It is necessary for everyone to read this letter and book very carefully. It contains important and necessary information.

Exhibits are only to be removed during specified times

→ All static exhibits are to arrive between

3 p.m. and 6 p.m. on Monday, August 12th & Tuesday, August 13th Exhibits may not be removed until

Sunday, August 18th between 5 p.m. - 7 p.m. August 19th between 3 p.m. - 5 p.m. Other times to be determined according to fair board schedule

Incidentals:

- 4-H Members who enter animals and static exhibits are encouraged to volunteer to support the 4-H Program at Fair time Work Bee Day (Friday, August 9th 9 a.m.-12 p.m.), Jr. Superintendent training at 1 pm.
- Books are available one per club as of July 15th. Additional copies are also available at the Cornell Cooperative Extension Essex County website: http://essex.cce.cornell.edu
- A fair entry form is enclosed for all static exhibits. Additional copies can be obtained from club organizational leaders or the 4-H Office (518-962-4810). http://essex.cce.cornell.edu/4-h-youth/essex-county-fair
- All exhibits, except livestock, must be listed on the fair entry form. List entries in order and bring the sheet with you when you bring your exhibits on August 12th & August 13th between 3 6 p.m. *No late entries will be accepted.*
- All small animal (poultry, rabbits) exhibits must be in place by 6 p.m. Tuesday, August 13th and *may not be removed before 5:00 p.m. on Sunday, August 18th*.
- All animal (goat, sheep, swine, dairy, beef, and horse) exhibits must be in place by 6 p.m. on Tuesday, August 13th and may not be removed before 5 p.m. on Sunday, August 18th.
- 4-H youth may exhibit in open class by following the requirements in the Fair Exhibitor's Handbook. You may
 request the Exhibitor's Handbook for Open Class from the Essex County Fair Office (962-8650) or website
 http://www.essexcountyfair.org
- You do not have to put your social security number on the double entry tags. However, if your exhibit is selected to be exhibited at State Fair and you wish to receive premium money, you will need to provide the 4-H office with your social security number.

- 4-Hers unable to be present on judging day must fill out an "Exhibitor Information Statement Form" that describes the completed project. Every exhibit will need a form attached. The forms may be found on the last page of this handbook. The form may be photocopied.
- Be sure to enter Department, Section, and Class Numbers on all entry forms and double entry cards.
- To receive premium money, 4-Hers must submit an end of the year progress summary report by September 30th.
- Cloverbud exhibitors are 5-8 years of age as of January 1st. Junior and senior exhibitors are ages 9-18 as of January 1st.

Livestock Exhibitors:

Check all ownership dates, health regulations, etc., very carefully. All sheep, horses, cows, goats and swine, must have rabies vaccination at least 14 days before fair. All livestock, including horses, must have project forms sent into the 4-H Office by July 31, 2024. There will be NO EXCEPTIONS TO THIS RULE.

Dog Exhibitors:

• Entries to be in the 4-H Office by <u>July 31, 2024</u>, on fair livestock forms.

Rabbit Exhibitors:

Cavies are entered in the Rabbit Department. Please note that there is a rabbit costume class.

Poultry Exhibitors:

• If you plan on exhibiting Poultry, call the 4-H Office (962-4810). Your flock may or may not have to be tested. Please note that there is a poultry costume class. Poultry must have pullorum testing for 2024 fair season. Pullorum testing will be available Tuesday, August 13th.

Home Economics Exhibitors:

• Read carefully the requirements in each section. Several classes require additional information on 3" x 5" cards. If these cards are not present on the exhibits they will be marked down one award.

Cloverbud Exhibitors:

- All exhibits, except animals, MUST be placed in **Department 029**, Section A, Class 1. Exhibitors will talk with judges about each exhibit.
- Hogs, Sheep, and Goats: Cloverbud members may complete projects with very young animals in these species. Goat and sheep classes for fair will be set up at the discretion of the show committee.
- All entries in horse, dairy, beef, poultry, and rabbit must be in specified Cloverbud classes.
- All Cloverbud exhibits including animals are not eligible for exhibit at State Fair.

~ RULES AND REGULATIONS ~

(Double entry exhibit cards may be obtained from the 4-H Office)

- 1. All static exhibits must be in the 4-H Exhibit Hall, located in the 4-H dairy barn, by 7 p.m. upon completion of judging on Tuesday, August 13th and may be removed Sunday, August 18th from 5 p.m.- 8 p.m or August 19th from 3 p.m. 5p.m., other times will be determined later.
- 2. All small animal (poultry, rabbit) exhibits must be in place by 5 p.m. **Tuesday, August 13**th and may be removed **Sunday, August 18**th at 5 p.m.
- 3. All large animal (goat, sheep, swine, dairy, horse, and beef) exhibits must be in place by 5 p.m. on **Tuesday, August 13**th and may be removed **Sunday, August 18**th at 5 p.m.
- 4. Classes are open to all enrolled youth members in Essex County by June 1, according to projects in which they are enrolled. Exhibits must conform to classes offered in the premium list.
- 5. Exhibits must be grown, made or prepared by the exhibitor during the current project year.
- 6. 4-H members must turn in 4-H Summary Reports before September 30, 2024 to receive their premium money from the fair.
- 7. 2 bags of shavings will be provided per cow, horse, sheep, swine and goat.
- 8. The Fair Association and the 4-H Program assume no responsibility in the event of loss or damage from any cause to livestock or exhibits and on this condition only are entries received. Times to remove your exhibits will be determined according to the fair board schedule.
- 9. All entries of dairy and beef cattle, swine, sheep, dairy goats, horses, and dogs must be in by July 31st, 2024 on special livestock entry forms. Forms may be obtained from the 4-H Office.
- 10. All animals must be owned by the exhibitor unless otherwise stated.
- 11. The 4-H Program assumes no responsibility for youngsters staying overnight on the Fair Grounds.
- 12. Kits are only acceptable where indicated.
- 13. All exhibits will be judged using the Danish System. Exhibitors are encouraged to be present with their exhibits while they are judged. However, if a 4-H member is unable to be present for judging arrangements must be made with Extension Educators to speak with a judge by telephone the day of judging or may submit an "Exhibitor Information Statement Form" (located at the back of the handbook) for each item exhibited which may be entered by another family and /or club member with prior notice for extenuating circumstances. All required paperwork must accompany each exhibit.
- 14. All exhibits (static & animals) for members enrolled as Cloverbuds must be placed in classes designated specifically for these members.
- 15. General animal health requirements:
 - (a) The owner or custodian shall keep show animals segregated from the herd or flock for a period of at

least 2 (two) weeks after Fair for biosecurity reasons.

- (b) The animal health requirements must be printed in each fair premium book.
- (c) No fair shall impose requirements in addition to, or different from, those requirements set forth under those parts.
- 16. All horses, cows, pigs, sheep, and goats must have been vaccinated for rabies at least 14 days before fair.
- 17. All youth showing small animals should dress in appropriate show clothing; white top and black bottom.

POINT SYSTEM

Continuing this year most awards will be made on a point system. Exhibits will be judged on a basis of Excellent (blue), Good (red), and Worthy (white). Amount of premium will depend on number of entries and exhibitors. See below for point system values.

DEPARTMENT 001 - VEGETABLES

Rules:

- 1. Exhibits must be grown, by exhibitor, as a project and be from garden of exhibitor.
- 2. Exhibit card must indicate variety name.
- 3. Vegetables to be exhibited on sturdy paper plates or in plastic baggies.
- 4. For information on exhibiting and judging vegetables consult the brochure, *Displaying Vegetables at Their Best*. Brochure can be obtained from project leader or 4-H Office.

SECTION A - GARDEN VEGETABLE CLASSES

Class No.

- 1. Beans, lima, 6 green pods containing edible beans
- 2. Beans, snap, green 10 pods
- 3. Beans, snap, yellow, 10 pods
- **4**. Beets, 3 tops trimmed to 1 inch, trim taproot to 1 1/2 inches
- 5. Broccoli, 1 head or bunch of small heads, 5 inches or more in diameter
- 6. Cabbage, 1 head, 2 to 4 pounds, with 3 to 4 wrapper leaves, any fresh market variety
- 7. Cabbage, 1 head, large size, with 3 to 4 wrappers leaves, any kraut variety.
- 8. Carrots, 3 tops trimmed to 1 inch, no green shoulders
- 9. Cauliflower, 1 head, leaves cut just above head
- 10. Celery, 1 plant, market quality, roots off
- 11. Chard, 1 plant, roots and damaged leaves off
- 12. Corn, Sweet, 3 ears, husks removed completely, shank trimmed to 1/2 inch, display in transparent bag
- 13. Cucumbers, 2 slicing types, 5 inches or longer, 2 inches or less in diameter
- 14. Cucumbers, 5 pickling type, less than 3 to 5 inches long
- 15. Cucumbers, 10 pickling type, less than 3 inches long
- 16. Dill, bunch of 6 seed heads, tied or in transparent bag
- 17. Lettuce, leaf, 1 plant, roots off, good market size
- 18. Lettuce, head, 1 plant, roots off, good market size
- 19. Onions, 3 tops trimmed to 1/2 inch, well cured and dried, not peeled
- 20. Onions, 6 green bunching type, tops on but trimmed evenly
- 21. Parsley; 1 plant, roots off, good market size and quality
- 22. Parsnips, 3 tops trimmed to 1 inch
- 23. Peppers, 2 large types such as Bell, Cubanelle, Italian Sweet
- 24. Peppers, 3 small types such as Banana, Hungarian Wax, Cherry, Jalapeno
- 25. Potatoes, 3 tubers, 5 to 10 ounces
- **26**. Pumpkin, 1 ripe, any pie variety
- 27. Pumpkin, 1 ripe, any field variety
- 28. Squash, summer, 2, young, skin tender, such as zucchini, yellow, scallop
- 29. Squash winter, 1, any large types such as Hubbard, Delicious, Banana
- 30. Squash, winter 2, such as Buttercup, Butternut, Spaghetti, Table Queen and Golden Nugget
- 31. Squash, 1 soft and round stem, largest by dimensions in exhibit period, such as Big Max, Big Moon, Mammoth
- **32**. Sweet potatoes, 3 roots, any variety
- 33. Tomatoes, 3 ripe, stems off or on, medium and large fruited varieties including Roma types
- 34. Tomatoes, cherry, ripe, 1 pint basket, stems off, also Presto and small fruited types

- **36**. Turnips, 3 tops trimmed to 1 inch

DEPARTMENT 002 - ORNAMENTAL HORTICULTURE

SECTION A - CUT FLOWERS

Rules:

- 1. Cut flowers will be displayed as brought in.
- 2. An exhibit shall consist of 3 stems with the same color blooms except as noted:

Gladiolus - an entry is **ONE** spike with at least 12-inch stem.

Roses - an entry is **ONE** stem of the type listed.

Dahlias - an entry is **THREE** blooms of one color, or **ONE bloom** if over 6 inches.

3. Stems should be eight inches long, except where type of flower makes this impossible.

- 5. Flowers that do not last as cut flowers (hollyhocks, four o'clock, and portulaca) may not be entered.
- 6. Blooms of weeds, wildflowers and shrubs will not be judged.
- 7. For information on exhibiting and judging flowers consult the brochure, *Exhibiting Flowers at Fair*. Brochure can be obtained from project leader or 4-H Office (518-962-4810).

SECTION B - INDOOR GARDENING

Houseplants must be single stem or crown in proportional container. All items should follow recommended guides of balance, design, proportion and harmony.

No artificially colored or plastic materials allowed in any class, with the exception of class #74. Ribbon and bows as part of design is allowed.

DEPARTMENT 003 – POULTRY Poultry Breed Show will be held on Thursday, August 15th at 2:00 p.m.

Health Requirements:

Poultry. To qualify for exhibition at fairs, poultry:

- (a) shall not originate from any state where the commissioner has determined that avian influenza highly pathogenic sub type H5 N2 is present. A list of such states is maintained at the offices of the USDA, 1 Winners Circle, Albany, New York 12235 and,
- (b) must be accompanied by results of a negative pullorum-typhoid test conducted within 90 days prior to the opening date of the fair or proof that the fowl originated directly from a U.S. pullorum-typhoid clean or equivalent flock. Waterfowl are exempt from this requirement. US pullorum-typhoid clean or equivalent must be done yearly.

Rules:

- 1. All birds must have been owned and cared for by the exhibitor since June 1, 2024.
- 2. Entries will be limited to 1 in a class except for in classes 26-30. Multiple class entries for birds of the same breed will not be allowed.
- 3. Birds will be judged on the production basis with emphasis on the major qualifications.
- 4. A cock or hen is a male or female bird respectively, hatched prior to January of the current year. A cockerel or pullet is a male or female bird respectively, hatched since January of the current year.
- 5. An entry in a single class cannot also be used in a trio class.
- 6. A poultry trio consists of 2 females & 1 male of all the same breed.

Class no. 50

Chicks – includes groups of at least three young baby chickens of any breed no more than 3 months of age that were hatched by the exhibitor in an incubator. The exhibitor will be expected to answer questions about the hatching and care of their chicks. The exhibitor must provide an appropriate cage and heat source apparatus. If special feed is needed, it should also be provided by the exhibitor. Birds of low vitality will not be allowed for entry.

Class no. 51

Poultry Costume Class (Ribbon Only) - Any costume which causes harm to the bird in any way will not be allowed.

Class no. 52

Rooster Crowing Contest *(Ribbon Only) – Any cock may be entered on the days prior to each contest. Separate contests will be held each morning on Thursday through Sunday at a pre-determined time. Roosters will be judged on loudness and frequency of crows within a ten-minute span. Roosters that win a crowing contest may <u>not</u> compete in another crowing contest during the week. Winners of each daily contest will be posted in the poultry barn.

DAIRY DEPARTMENT 004 - PUREBRED ANIMALS DEPARTMENT 005 - GRADE ANIMALS

Health Requirements:

- (1) Must be identified by an USDA approved official eartag, tattoo or registration papers.
- (2) Health certificate (with animals individually identified) completed within 45 days of opening date of fair.
- (3) Must have proof of vaccination against rabies at least 14 days before fair.
- (4) Bovine respiratory disease complex cattle three months of age and older must show proof of being vaccinated against the common bovine respiratory disease viruses in order to provide active immunity prior to arrival on the fairgrounds. <u>Vaccination MUST include immunization against bovine viral diarrhea (BVD)</u>, bovine respiratory syncytial virus (BRSV), infectious bovine rhino tracheitis (IBR) and Parainfluenza (PI).
- (5) Observe milk & drug/vaccine labeled withholding times.

Rules:

- 1. **4-H Cattle entries must be in the 4-H Office by July 31**st. Use special livestock form.
- 2. No animals may be exhibited that are not properly fitted.
- 3. All cattle exhibited as purebreds must be registered in the club member's/farm name as of May 15, 2024. No more than two entries in a class by same exhibitor.
- 4. All project animals to be on file in the 4-H office by June 15th.
- 5. All exhibitors are expected to participate in the appropriate showmanship class unless excused by superintendents.
- 6. Exhibitors must care for and show their own animals.
- 7. Exhibitors must furnish their own grain, hay, water pails and feed buckets. Bedding will be furnished by the Fair.
- 8. All 4-H Dairy and livestock will be judged in the open show.
- 9. Grades and Registered animals will be shown in the same classes. Registered animals will continue to receive a higher premium.
- 10. 4-Hers must have participated in **one** county-wide dairy clinic and/or dairy camp to be eligible for this show.
- 11. No Cloverbud will be allowed in the ring without being accompanied by a responsible person over age 18.
- 12. All beef and dairy cattle with the exception of Highland cattle entries must be dehorned or naturally polled at the state level.
- 13. No bulls over one year old allowed.

Each 4-Her must show his/her own animals, but during the course of the contest they may be asked by the judge to show some other animal.

The Judge in making the awards shall consider the following points:

Preparation of the animal for showing:

- 1. Condition of feet and trimming of toes.
- 2. Condition of the head, ears, tail, etc.
- 3. Cleanliness and condition of the hide and hair.

Showing the animal:

- 1. Control of the animal by the exhibitor.

General Rules:

- 1. All 4-H horses must conform to the rules and regulations as outlined in the New York State Department of Ag and Markets Livestock Health Requirements.
- 2. 4-H exhibitors must meet county 4-H Horse Project Requirements for showing at the Essex County Fair. This includes participation in 3 county events (Public Presentation, hippology, horse bowl, horse camp, horse clinics, and Miner Institute) conducted from July 2023 through June 2024. In addition, 4-H participants must have been evaluated with each animal they exhibit.33
- 3. All horses must have been officially designated as the 4-H member's project animal by June 15th of the current year, with a copy of the completed certificate on file in the 4-H office. 4-H members may designate all personally or family owned equine as project animals. (Family will be defined as the parents, stepparents, legal guardian, husband, wife, child, brother, sister, stepchild, half-brother, half-sister, grandmother, grandfather, and in-laws of the same relation.) 4-H members not owning or using a personally or family owned equine may designate one non-owned equine as their project animal.
- 4. Mares with foals at their side and stallions may not be brought to or exhibited in the 4-H Horse Show.
- 5. Any project animal that is lame, out of condition, improperly trained, out of control, or a danger to exhibitors or others will be disqualified & dismissed from the 4-H Horse Show.
- 6. All riders must wear an approved ASTM SEI safety helmet and appropriate heeled footwear when riding, driving, or working with a horse on the Fairgrounds.
- 7. Horses may not be ridden in the barn and must walk in the barn area.
- 8. Stalls will be assigned.
- 9. Entries must be on Special Livestock Forms and turned in to the 4-H office by July 31st.
- 10. 4-H exhibitors are encouraged to enter all classes they may possibly want to participate in as there will be no adding of classes on the day of the show.
- 11. Exhibitors may enter English, Western, and/or Gymkhana classes with the same animal.
- 12. All exhibitors, except Cloverbuds, <u>must</u> enter Fitting and Showmanship and may only enter one animal in this class.
- 13. **Cloverbud exhibitors are 5-8 years of age as of January 1st

Rules:

All 4-H dogs must conform to the rules and regulations of the Livestock Health requirements as outlined in this premium book.

- 1. Open to Essex County 4-H members who have completed the **4-H Dog Obedience Program** during the current 4-H Club year.

General Guidelines for Grooming and Handling Classes:

Scoring to determine the award of ribbons will be based on the following:

The appearance of the animal (Grooming) will account for 45 points and the showing (Handling) of the animal will account for 45 points. Knowledge of handler (appropriate to the class level) will account for 10 points. Maximum possible points will be 100points. Ties will be broken based upon knowledge of the handler.

- <u>Discriminating use of bait</u> (food, toy, etc.) will be allowed in grooming and handling classes but is not mandatory. Inappropriate baiting will be penalized.
- Gaiting Patterns Dogs should be moved at a trot. How smoothly a pattern is performed is more important than the actual mechanics of it (i.e., which hand switched where). 4-Hers should strive to keep their dogs between themselves and the judge where possible. 4-Hers in all divisions will be expected to be able to gait their dog in a circle, a triangle and in a straight line. The straight line may be on the diagonal of the ring or parallel to a side of the ring. 4-Hers in Grooming and Handling division B will additionally be expected to be able to gait their dogs in an "L" pattern and also in a straight line paired with another 4-Her and his or her dog.

DEPARTMENT 012 – RABBIT & CAVY Rabbit Fun Show August 15th @ 1:00 pm

The classes below (except for the Other Classes) are showmanship classes which are judged on the appearance of the exhibitor and animal, exhibitor's actions, and the exhibitor's knowledge. 4-H'ers should know the breed and class of their rabbit, age group terminology, parts of the animal and basic care.

- 1. Rabbits are not required to be vaccinated
- 2. Rabbits may be entered in more than one section
- 3. All 4-Hers must enter showmanship with one rabbit only, the same and other rabbits may be shown in other 'Type' sections and/or Pure-Bred section.
- 4. Multiple rabbits may be entered. At least one cage per exhibitor will be provided. Each rabbit must have its own cage. If you bring more than one rabbit, please be prepared to supply your own cages. Final caging availability will be determined by the number of entries.
 - 5. Bucks and does of any age will be shown at the same time in each section.
- 6. Age of exhibitor will affect showmanship (SH) classes only. Please enter appropriate age/class# for showmanship. Any age 4Hers will be able to enter all other divisions. Cloverbuds may have an adult assist in carrying or placing rabbits on the judging table.
- 7. Showmanship classes (SECTION SH class#1-3 cloverbud, junior, senior) are judged on appearance of the exhibitor and animal, exhibitors actions, knowledge and terminology, condition and evidence of basic care, parts of a rabbit, breed or type (for ex). Questions may be asked of the exhibitor at time of judging.
- 8. Rabbits entered in Sections A-F are not required to be pure-bred animals. They will be judged according to body type, health, and condition. (Eye color, toenail color, off-standard colors will not be faults or DQ's in these sections/classes).
- 9. Purebred rabbits entered in division PB do not require pedigrees or proof of breed purity but will be judged against the ARBA standard of perfection for the respective breed. (NOTE: pure- bred animals may be disqualified or faulted depending on breed standard). Purebred division is designed as a basic introduction to open ARBA-style rabbit show criteria.
- 10. BEST in SHOW(BIS) and RESERVE in SHOW(RIS) will be chosen from the first-place winners of each division except SH (showmanship)
 - 11. A purebred rabbit may be entered in both its TYPE division(A-F) and PB (purebred division).
- 12. Animals showing signs of distress or disease will not be admitted to the fair or will be removed immediately if symptoms develop during the fair.

A few examples: New Zealand, Satin, Californian, French Angora, Silver Fox, Champagne D'Argent, Palomino, Rex, and crosses.

Dividing the class at time of show is at the discretion of the judge.

- 3. There is no limit of entries in any class providing each item is different.

Articles made in wood science project, from a kit in which the member has not made the exhibit entirely, but has assembled pre-cut materials and/or has applied an appropriate finish. (This includes articles that the leader cut out materials and member assembled.)

Articles made in a wood science project, made entirely by the member.

An article made in an electric project, such as a portable bench light, extension cord, pinup or study lamp, circuit boards, rewiring an old lamp, etc. Judging emphasis based primarily on electric techniques and skills.

An article made as a part of a related 4-H Project, such as saddle bags (horse), poultry hook (poultry), and rope halter (dairy), and not included in class 1 or 2.

DEPARTMENT 016 - PHOTOGRAPHY

Rules:

- 1. All photographs must have been taken by exhibitor as part of the 4-H photography project during the current 4-H year. No exhibitor may enter more than one exhibit per class. All exhibits <u>must be mounted on sturdy background with hanger</u>. Exhibits will be judged on technical quality, composition, storytelling ability and preparation of exhibit. All exhibits should be titled.
- 2. No photographs to be smaller than 3 ½" x 3 ½" nor larger than 8" x 10". Adjacent to each photograph <u>must</u> <u>be a title or caption</u> to assist the viewer to interpret the photographic message. Exhibit preparation to demonstrate good workmanship and use of materials.

SECTION A - Prints

- Class No. 1 Single Photo Black & White Enlargement
 - 2 Single Photo Color Enlargement
 - 3 Photo story composed of 4 to 8 prints of similar size
 - 4 Photo Study Class. Shall consist of one of the following:
 - a) 4 photos demonstrating 4 methods of isolating the subject, not more than 3 objects permitted in each photo.
 - b) 4 close-up photos with a different main light source in each front, side, back and diffuse.
 - c) 4 photos each to illustrate one idea, i.e., hidden lines and shapes, framing, patterns, perspective or texture. Show differences same topic, different location, angles, etc.
 - 5 1-3 photographs developed and printed by exhibitor and properly mounted.
 - Darkroom technique up to 4 enlargements. 8" x 10" maximum size. Use film you processed and picture you printed. Attach contact print of each negative. Indicate control techniques used, if any, including spotting. For color enlargements indicate process used: color printing paper or enlarging film.

SECTION B - Slides

- 7 Individual color slide. (Note: slide should be displayed in protective cover and labeled with name and address).
- **8** Slide story composed of 5 to 7 slides displayed in protective cover accompanied by a written script.

SECTION C - Video

13 Video Project – Video submitted must be at least seven minutes in length. All video to feature a 4-H project or activity. Judging criteria to include technical quality, organization and communication of message, and creativity in approach. Project can be submitted as CD or DVD.

SECTION D – Digital Images

- Class No. 10 Single unedited digital image Picture comes straight from the camera without any modification.
 - Single slightly edited digital image Image has been somewhat digitally edited or enhanced. Modifications may include: cropping; sharpening or blurring; brightness or contrast changes; or the

- addition of text. Thumbnail of the original image shall accompany exhibit.
- 12 Single heavily edited digital image Image has radically digitally edited or enhanced. Modifications may include: addition to or the removal of parts of the image; changes in the color scheme of the image; the use of filters or effects; or animation using digital images, etc. Thumbnail of the original image shall accompany exhibit.
- 13 Story composed of a 4 8 digital images of similar size If edited images are used, thumbnails of the originals shall accompany exhibit.

DEPARTMENT 017 - CLUB EXHIBITS

SECTION A

An entry form with club's name needs to be filled out for all club exhibits.

Class No. 1

Club Exhibit should show some phase of the 4-H Club's Program during the current 4-H year. Clubs are urged to exercise their originality and initiative. The club exhibit should represent the combined efforts of all members. 3' x 5' space available.

Class No. 2

Club Banner - only new banners may be entered

Class No. 3

Other Educational Exhibits are for clubs to highlight a particular project or activity their club participated in the current 4-H year that does not result in exhibits that can be entered by 4-H members. This might include such projects as Small Engines, Maple Syrup, Outdoor Cookery, Baby Sitting, First Aid, etc. This could be a static or working exhibit. 3' x 5' space available.

DEPARTMENT 018 - ACHIEVEMENT BOOKS AND RECORDS

SECTION A

Class No. 1

Achievement Books - open to all club members in grades 3 -12 to include cover, records and achievement of years in club work. Emphasis will be placed upon **current 4-H year's activities** and general appearance.

Class No. 2

Secretary's Record Book

Class No. 3

4-H Project Notebook or kit assembled as part of project work. No limit on entries.

DEPARTMENT 019 - NATURAL RESOURCES

Rules:

- 1. All entries must be labeled with a tag giving name, age, address, county, and name and class number of exhibit and a brief project story. The project story should include an explanation of the project why the project was chosen, what steps were followed in developing the project and how the project will be used.
- 2. Exhibits showing processes, products, skill development, and relevance to environmental/natural resource issues are strongly encouraged. Each exhibit should be self-explanatory or self-interpretive. Overly simplistic or non-interpretive exhibits should be avoided.
- 3. Exhibits will be judged on the basis of their content, quality of expression and presentation. Creativity is encouraged as is display of materials showing observational skills, i.e., journals or sketch books. Age, experience and standards listed in appropriate 4-H publications will be included in the judging criteria.

SECTION A - Environmental Education

Class No. 1

Nature trails - e.g. Display of 4-H constructed nature trail or observation made along another nature trail.

Class No. 2

Geology - Simple collections must include a minimum of 15 specimens properly identified, labeled and mounted. Labels must show the specimen's name, date of location, specific site of collection (distance and direction to nearest town, county, state or province) and collector. Inclusion of field journals is strongly encouraged, and identification criteria must be completely and clearly defined. Exhibits showing evolutionary histories, vertical or horizontal studies of strata, etc., are encouraged.

Class No. 3

Fun with Fungi - Simple collection must contain dried examples of at least 5 different kinds of fungi, each clearly labeled. Other items that can be included in this exhibit are line drawings illustrating the parts of a mushroom, line drawings illustrating different types of mushrooms that were not available for the dried collection, spore prints of one or more mushrooms. This exhibit is eligible for display only at State Fair and will receive a ribbon of participation.

Photo Exhibits - Photographs of fungi may be displayed according to the General information in the Photography Section. Fungi in photos must be identified by their common name and/or scientific name. Include with the title or caption the date and location of the photo. Suggestions include:

- 1) Photograph of a single fungus or group of fungi
- 2) A collection of three or more photographs of different fungi.
- 3) 4 close up photographs, taken hours, days or weeks apart, showing the growth and development of the same mushroom
- 4) 3 photographs taken one each during spring, summer and fall.

Class No. 4

Field Identification Projects - Collections of preserved specimens, photographs or sketches properly labeled and showing identification criteria may be displayed for any habitat in New York. Any taxon may be selected.

Class No. 5

County or self-initiated projects (e.g. Do Your Own Thing) that fits this category, e.g. vegetation maps, plant phenology, demonstrations of ecological principles, computer models or similar synthesis. Transfer of display ideas and concepts from other project areas is encouraged.

Class No. 6

Insects All Around Us - An exhibit will consist of item(s) developed as the result of the project completion such as collecting and observing devices as described in project materials, "shake-it box", pitfall trap,

homemade butterfly net, model of an insect showing the body parts; information about one or more of the following: insect life cycles, different orders or groups of insects, parts of the body, how insects differ from other invertebrates, or different mouthparts, presented in a notebook, poster, or other creative means.

SECTION B - Fisheries & Aquatic Resources

Class No. 7

SAREP - Exhibits may be displays or records of any SAREP and/or National 4-H Sports Fishing related activity including but not limited to fishing techniques, aquatic sampling methods, aquatic insect ecology, habitat improvement, or fisheries management and biology. Consult the SAREP manual, available from SAREP office or *Pond and Stream Safari* and National 4-H Sport Fishing curricula for additional ideas.

Class No. 8

Other fishing projects may be found in 4-H Publications.

Class No. 9

Water monitoring - project ideas may be found in Water Worlds, Water Wise, Pond & Stream Safari.

SECTION C - Forestry

Class No. 10

Displays and presentations may be based upon, but are not limited to, the following projects: *Know Your Trees, Timber Management for Small Woodlands; Wildlife and Timber from Private Lands: A Landowners Guide to Planning; Woods of New York; Maple Syrup Production for the Beginner; Trees: Dead or Alive;* and other or self-initiated projects such as the 4-H Forestry and Wildlife Invitational.

SECTION D - Resource Based Recreation

Please remember that a project story must be included, giving complete explanation of the project and its relevance to natural resources and environmental education.

Shooting Sports - any exhibit or record based upon content of the NYS Shooting Sports Programs or any of the New York State DEC certification programs.

Class No. 12

Other Outdoor Recreation - Exhibits based upon related outdoor recreation activities, e.g. orienteering, cross-country skiing, snowshoeing, wilderness camping, or outdoor cookery.

SECTION E - Wildlife

Class No. 13

Bird Study - Consult *Bluebirds of New York*, *Birds of Prey, Introduction to Bird Study*, or any other bird materials for exhibit ideas. **If a birdhouse is exhibited under the wildlife section please remember that a project story must be included, giving complete explanation of the project and its relevance to natural resources and environmental education.**

Class No. 14

Habitat Improvement - consult Wildlife Habitat Enhancement, Enhancement of Wildlife on Private Land, Managing Small Woodlots for Wildlife, and Plants for Improving Wildlife Habitat Around your Home for exhibit ideas.

Class No. 15

Trapping Furbearers - Exhibits based upon the NYS DEC Trapper Training Program are acceptable, as are displays of equipment, pelt preparation, and discussions of the role of trapping in wildlife management.

Class No. 16

Other Wildlife Projects - Exhibits based upon New York's wildlife resources, *Environmental Awareness: Wildlife, Managing Small Woodlots for Wildlife; Plants for Improving Wildlife Habitat Around Your Home; Wildlife Discovery*; and *Wildlife in Today's Landscapes*. County projects or self-initiated projects are acceptable. A good source of potential project is the 4-H Forestry and Wildlife Invitational.

DEPARTMENT 020 - FOOD PRESERVATION

Criteria for Exhibiting Home Canned Foods:

✓ Remember: use only United States Department of Agriculture (USDA) tested and approved recipes.

The USDA has researched, tested and approved recipes for home canning. In order to obtain a safe, quality product use only up-to-date (1994 or later) USDA approved recipes. Approved recipe sources include:

National center for Home Food Preservation at, So Easy to Preserve,

University of

Georgia, Ball® Blue Book, Cornell Cooperative Extension Office (962-4810)

- ✓ Canned exhibit consists of one clear-glass Standard Mason jar processed with a self-sealing, two piece lid. (metal lid and metal ring).
- ✓ Jars must be free of cracks, chips, etc.
- ✓ Each exhibit must be vacuum sealed.
- ✓ Rings should have been removed after processing and cooling in order to clean and store the canned good. Rings should be put back on for transport, but removed for judging.
- ✓ Top of jars must be labeled with the product and date processed. Do not put labels on the sides of the jars (this makes it difficult for judges to view the product).
- ✓ Attach a separate card securely to the exhibit and include:

Recipe

The card should include the following information if not already included in the recipe:

Contents

Type of pack (hot or raw)

Type of processing (boiling water bath or pressure canner)

Processing time

Altitude adjustment if required

Headspace

Date of processing

- ✓ Appropriate head space requirements must be followed. In general Fruit Juices ¼ inch; Vegetables ½ inch; Jams and Jellies ⅓ inch; Pickles ⅓ inch; Tomatoes ⅓ inch, or according to USDA approved recipes.
- ✓ The following entries will be disqualified:

Foods processed and packages not following current (1994 and later)

USDA recommendations

Paraffin sealed jams and jellies

Jars with zinc lids

Foods in green jars or non-standardized jars

Jars with more than 2" headspace

Jars with added color, bleach, sulfite or other preservatives, unless called for in a USDA approved recipe. (For example, baking soda may not be added to green vegetables)

Jars or food that were made and processed over one year ago

 - o Pre-treatment method (if used)

A card should include the process used to make the syrup and the resources(s) of their information. Made by a member 8-18 years of age as of Jan. 1, 2024.

Honey Products- Comb Honey, Creamed Honey, Honey. An exhibit will consist of homemade Honey products in a clear container appropriate for syrup products. A card should include the process used to make the honey and the resources(s) of their information. Made by a member 8-18 years of age as of Jan. 1, 2024.

DEPARTMENT 021 - BAKING

Rules:

- 1. All baked entries must have been baked from scratch by the exhibitor. No refrigerated or frozen dough or box mixes are permitted. Use of bread machine is not allowed.
- 2. No exhibits requiring refrigeration (cream or custard-based pies, cakes) are allowed.
- 3. Remove all items from baking pans (except pies, use disposable pie plates) and exhibit on paper plates or foil-wrapped cardboard. Do not bake muffins or cupcakes in paper liners. Loose granola and trail mix should be in an air tight container, either clear ½ pint zip closure bags or glass jars with tight fitting lids.
- 4. Include recipe card (product name, ingredients, preparation steps, and yield) with all baked entries.
- 5. An exhibit is: 3 samples of small items (cookies, muffins, cupcakes, rolls, breadsticks, pretzels, granola bars or similar products); ½ of large item (loaf bread, cake, coffee cake, or similar products); <u>or</u> whole item if needed to convey appearance of product (pie, turtle-shaped bread, or similar products); 3 samples of ½ cup loose granola or snack mix.
- 6. Each exhibitor may enter up to 3 exhibits per class.

SECTION A

Class No. 8

Cookies, drop or hand-shaped. Examples: drop-chocolate chip, applesauce, oatmeal; hand-shaped peanut butter, snickerdoodles, crinkles. No frosting; hand-shaped cookies can be rolled in sugar.

Class No. 9

Cookies, pan-baked. Examples: date bar, pumpkin bar, brownies or other batter cookie (<u>not</u> layered pan cookies). No frosting or added decorations that are not part of the batter.

Class No. 10

Class No. 13

Muffins - plain, whole wheat, cornbread, bran, apple, or other. No toppings.

Class No. 14

Biscuits or Scones - plain, whole grain, flavored, or other shaped (rolled & cut) biscuits or scones. No toppings.

Class No. 15

Loaf Bread (<u>not</u> yeast leavened). Banana, blueberry, apple, pumpkin, or other bread baked in 9x5 or 8x4-inch pan.

Class No. 16

Yeast Rolls. Plain, whole grain, flavored, or other yeast rolls of any shape; does not include fancy rolls with fillings or frosting.

Class No. 17

Yeast Bread. Plain, whole grain, flavored, or other baked in a 9x5 or 8x4-inch loaf pan.

Class No. 18

Shaped Bread. An exhibit is any small (such as pretzels or breadsticks), or large (such as animal shaped) hand shaped bread. Plain, whole grain, flavored, or other; does not include fancy yeast breads with fillings or frosting.

Class No. 19

Baking Light. An exhibit is sample of any baked product that is made with less fat and total calories by (1) modifying a recipe (include original and revised recipe); (2) using an already modified recipe; (3) making a traditionally low fat product such as angel food cake. The recipe and explanation of why it is low in fat must be included. Cookies, loaf bread, cake, cupcake, coffee cake, muffins, pies, or other baked items.

Class No. 20

Grown in New York. An exhibit is a sample of any baked product that contains a fruit or vegetable grown in New York State and must include: (a) recipe, (b) explanation of ingredient grown in New York, including where it was grown and purchased and if it was preserved for later use. Source of ingredient can be garden U-pick or roadside stand, farmers market, or any market if source can be identified. Cookies, muffins, bread, cake, cupcakes, coffee cake, pie or other baked items.

Class No. 21

Heritage Foods. An exhibit is sample of any baked item associated with family traditions or history and must include: (a) recipe and (b) family history and traditions associated with the food. Cookies, muffins, bread, cake, cupcakes, coffee cake, pie, or other baked items.

Class No. 22

International Foods. An exhibit is sample of any baked item associated with customs and traditions of a country or population of the world and must include: a) recipe, b) historical background or context, and c) traditions associated with preparing, serving, and eating the food. Cookies, muffins, bread, cake, cupcake, coffee cake, pie, or other baked items.

Class No. 23

Animal Treats

Class No. 24

Granola. Loose or bar form.

Class No. 25

Snack Mix. Savory or sweet.

DEPARTMENT 022 - CLOTHING & TEXTILES

Rules:

- 1. In addition to the entry tags, a card must be fastened inside hem or lower edge of garment with the following information:
 - a) Name of exhibitor
 - b) Years in textiles and clothing (4-H or school)
 - c) Fiber content of item
 - d) Care label information
 - e) At least 3 things learned while constructing the item
- 2. Garments not completely and/or correctly labeled will be marked down one placing.
- 3. If a kit is used for down or fiberfill items or outdoor equipment (i.e. parka, hood, booties), this must be stated on the card and the instruction sheet(s) must be firmly attached to the items.
- 4. Each exhibitor may enter up to 5 articles in either class 1, 2, and 3.
- 5. Each exhibitor may enter up to 2 articles in class 4.
- 6. Each exhibitor may enter up to 1 article in class 5 and 6.

SECTION A

Class No. 1

Beginning Clothing - any simplified article made in the 4-H Adventures in Clothing project. Articles might include apron with or without potholder, T-top, wrap skirt, beach wrap up, duffle bag, equipped sewing box, felt items made for sewing box, or jams.

Class No. 2

Intermediate Clothing - any intermediate level garment made in the 4-H Challenges in Clothing project. Articles might include skirt or blouse; slacks or skirt with a waistband, darts & zipper; jumper, simple down or fiberfill jacket or vest; backpack.

Class No. 3

Advanced Clothing - any article showing superior accomplishments made in the Strategies in Clothing project. Articles might include detailed dress, suit, sport or dress coat; garments made of a special fabric such as wool, uneven plaids, velvet, fur, silk or ultra-suede.

Class No. 4

Article made for use in other project area (article from the Clothes Horse Project, riding outfit, dairy showmanship outfit, etc.)

Class No. 5

4-H Mannequin Modeling - members will be able to mannequin model an outfit which was completed as part of a clothing and textile project. Modeling will be done during a two hour time period selected by the member.

Class No. 6

Purchased Garment: Garment or outfit accompanied by an 8½" x 11" information notebook. The notebook must include the following:

- 1) color photo of entrant wearing garment or outfit;
- 2) cost of garment include price tags, itemized comparison of cost to make garment. Consider cost of fabric, notions, pattern, labor, etc.;
- 3) story that describes: a) why garment was purchased, b) how it fits into wardrobe, c) fabric content and care, d) accessories selected, and e) activities for which garment will be worn.

DEPARTMENT 023 - HOME IMPROVEMENT

Rules:

- 1. Attach to each exhibit a 3 x 5 card with the following information:
 - a) name and age of exhibitor;
 - b) number of years in Home Improvement work;
 - c) color scheme in room where article is used;
 - d) how or where article is used in room.
- 2. Limit two (2) entries per class.
- 3. Objects whose ultimate use is to hang on the wall must have mountings on them and be ready for hanging.

Major item of fabric furnishings such as a bedspread, coverlet, quilt, dust ruffle, table covering, curtains, draperies. Additional information required: fiber content.

Class No. 2

An accessory item selected, constructed and finished by exhibitor such as:

Fabric: pillow, door pocket, padded picture frame, stretcher art, etc.

Wood (natural or painted finish): shelf, magazine rack, picture frame, etc.

Combination of Materials: bulletin board, lamp, etc.

Class No. 3

A piece of furniture of natural or painted finish done by exhibitor such as: a chair, table, chest, bookcase, etc. New unfinished, refinished or constructed by exhibitor. Additional information required: method of refinishing and/or finishing.

DEPARTMENT 024 - CHILD CARE / HEALTH & SAFETY

SECTION A

Picture Book - a durable book made for children, cloth or paper story or activity book.

- 1. Kits and printed designs will be permitted. If either is used, it must be stated on the entry card and the instruction sheet(s) must be firmly attached to the item. These exhibits are eligible for display only at State Fair and will receive a ribbon of participation.
- 2. All entries must be appropriately displayed, stretched, matted, framed, etc., in other words, in finished, ready-to-be used state. Objects whose ultimate use is to hang on the wall must have mountings on them and be ready for hanging.
- 3. There is a limit of 3 entries per class providing each item is different.

These 4-H Junior Superintendents **must** develop a working demonstration before the Fair. Demonstrations should be planned to take no more than 1/2 hour. One presentation will be given daily (time should include set up, clean up and question period). Participants are expected to bring their own supplies, visuals, etc., to explain their subject.

NEW YORK STATE FAIR

Exhibits will be selected for entry in the 4-H classes at the New York State Fair based on classes available and quality of exhibits. Please be aware that each individual is responsible to bring their exhibits to state fair if they wish to have it displayed. Cooperative Extension will not be transporting the exhibits.

WINNING ISN'T EVERYTHING BUT...

Too often, people plan too much emphasis on winning and losing in 4-H and not enough on the real value, the lessons learned.

This is not to say that parents should not encourage children to do their best to win but, on the other hand, winning is not the bottom line to success in the 4-H Program. Positive thinking has proven to be important to success in most fields of work.

Several skills can be gained as a 4-H Member:

- ➤ How to get along with people is important in everyday life. 4-Hers learn to cooperate with others. They meet new people who have the same interests and learn other interests through new friendships.
- > Sportsmanship, where most 4-Hers who show or exhibit for any period of time experience the thought of winning and the disappointment of losing. Both are important. Life isn't all peaks but has a good number of valleys. It is not uncommon to see those who did not win congratulate the winner, and the winner often has something nice to say to those who did not win.
- **Responsibility**, a good habit to learn at a young age. Hardly anyone is successful in life who is not responsible.
- ➤ **Decision Making** is never easy at any point in our lives. The 4-H project offers an opportunity at a young age to make decisions.
- ➤ **Goal Setting** will depend on the individual, his or her age and experience. The important point is to set a goal.
